

Titan Gift Card Terms and Conditions

Redemption

Titan Gift Card ("Gift Card") may only be redeemed for store credit such as gas, lottery tickets or store merchandise. The Gift Card cannot be used for alcohol, tobacco or firearms.

When using the game credits, game play is deducted from the Gift Card balance. Any unused balance remains dormant until the player uses it to play an Ultra game or redeem for store credit. Only that specific store can redeem their credits.

Gift Cards are given free to players that want to manage their play time and store visits.

To view your Titan Gift Card game credit balance, a player can request from the store clerk or check the balance at the Game Machines themselves. Any portion of any Gift Card balance can be used to redeem store merchandise as described accordingly. No minimum is required.

Limitations

Gift Cards may be redeemed for store credit such as gas, lottery tickets or store merchandise. Gift Cards can be reloaded with additional game credits, but cannot be resold, transferred for value or redeemed for cash, except to the extent required by law: gas, lottery tickets or store merchandise.

Risk of Loss

We are not responsible if any Gift Card is lost, stolen, destroyed or used without your permission.

Fraud

We will have the right to close the **customer accounts** if we find the players are acting inappropriately with their Gift Card game credits within the store of play or abusing cardholder ownership, including use of another player's card. If a fraudulently obtained Gift Card is redeemed and/or used to obtain store merchandise we have the right to stop usage of the Gift Card at any time.
